### State Street Commission Meeting Dates

The following are the 2025 meeting dates for the State Street Commission, tentatively selected mandated SSA agenda items, and deadline projections required by the city. (Emergency meetings may be called if warranted.) The location of the meetings will generally be at ABC7, 190 North State Street, on the 10th Floor, but prior to each meeting, the location will be confirmed, posted, and emailed in a reminder notice.

**Tuesday, January 21, 2025 at 2:00 PM** – Commissioners must review and approve 2025 Contractor's affidavit and performance assessment. Fourth Quarter & 2024 Year-End metrics and expenses are reviewed and approved by Commissioners. Due to the city by January 31.

**Tuesday, March 18, 2025 at 2:00 PM** – Agenda to be announced.

**Tuesday, April 22, 2025 at 2:00 PM** – **Note this is the 4<sup>th</sup> Tuesday of the month due to Tax Day falling on the 3<sup>rd</sup> Tuesday.** Commissioners must review the 2024 SSA #1 -2015 audit and vote to accept or reject it. First Quarter performance and expenses are reviewed and approved by the Commission. Look at the first draft of the 2026 work plan and budget. City and County ethics statements for SSA Commissioners are due by May 1. Final 2024 SSA Audit due by May 1.

**Tuesday, June 17, 2025 at 2:00 PM** – Agenda to be announced.

**Tuesday, July 15, 2025 at 2:00 PM** – EAVs are released mid-July. Commission reviews and votes on the 2026 work plan and budget (making any adjustments for EAV changes) which needs to be finalized and sent to the city. The Second Quarter performance and expenses are presented and approved by the Commission. Due by July 31. **Note: Commission may vote to hold this meeting earlier in the month.**

**Tuesday, October 21, 2025 at 2:00 PM** – Third Quarter performance reporting with expenses are presented and approved by the Commission. Due by October 31.

**Tuesday, November 18, 2025 at 2:00 PM** – Agenda to be announced.
